Bidding is open to all eligible Nepalese Bidders.
- 2. The Gurbhakot Municipality, office of the Municipal Executive surkhet electronic bids from eligible bidders for the construction and completion of Building Projects mentioned in the "The works" under National Competitive Bidding procedures.
- 3. In Case of Contract no NCB/WORKS/GM/04/2077-78 Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Work experience of similar Quantity, size and nature
 - Minimum two official Building construction completed Experiences compulsory.
- 4. Bidders, submitting their bid electronically only, should deposit the cost (as specified above) of bidding document in the Gurbhakot Municipality (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 6. Electronic bids must be submitted PPMO website www.bolpatra.gov.np/egp on or before 12:00 pm on 2077/08/05 Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 2077/08/05 at the office of Gurbhakot Municapality, Surkhet. Bids must be valid for a period of 90 days after bid opening and must be scanned copy of the bid security in pdf format. amounting to a minimum as mentioned in The works" below, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
